RELEASE OF LIABILITY AND AUTHORIZATION FOR MEDICAL TREATMENT

By signing below, you acknowledge, agree, warrant and covenant as follows:

I would like for my child to participate in The Beautiful Game Soccer Camp, sponsored by CCSL. I consent to such participation and acknowledge that such participation is optional. I realize that camp players will be participating in soccer skill activities and games, and that my child may be exposed to some level of injury or risk during camp. Furthermore, in consideration of CCSL allowing my child to participate in this camp, I do hereby release and relinquish Andy Lyon Soccer Camps and Coffee County Soccer League, their agents, and officers against loss or injury (including reasonable attorney fees), from any and all claims, or causes of action of any kind that may be brought by or on behalf of me or my child arising out of any and all known or unknown bodily or personal injuries, damages to property or consequences which may be sustained in connection with my child's participation in this camp, except such liability as may result from gross negligence on the part of Andy Lyon Soccer Camps or CCSL.

I hereby give my consent for emergency medical and/or dental care in the event of an injury associated with a soccer camp. I will accept responsibility for all payment of these services.
